*Sir / Madam,*

Indian Medical Association Ponda Branch has conceptualized Palliative Care facility concept in Goa. This facility is existing in few other states and Kerala has been on the forefront. Govt. of Kerala has made special provision to support such projects in their State. Government of Goa has no facility in the existing scenario of Health Services or Goa Medical College to provide Medical Services to terminally ill patients in terms of Palliative Care, Pain management and care-giving in life-limiting illnesses.

DILASA is expected to provide all such facilities under one roof and give relief to the citizens requiring such facilities. IMA Ponda members have experienced the difficulties in managing Terminally ill patients and decided to create such a facility in the state.

DILASA is a dream project of IMA Ponda and expected to be completed by December 2016. Estimated project cost of Rs 2.5 crores has inflated to Rs 3crores. Apart from initial and ongoing contribution from IMA members, we are also getting support from Philanthropic Industrialists, sponsor under MPLAD Scheme and well-wishers within and outside the state.

IMA Ponda has started donation drives, and organized charity shows and health awareness programs to raise funds for starting and maintenance of DILASA.

In order to sustain the administrative responsibility and provide tax benefit to our esteemed donors, IMA Ponda has formed a Trust in the name of "IMA PONDA CHARITABLE TRUST"

The response from donors till date has made us realize that we are following the right path towards Community Health Project, which is an addition to the existing 36 projects in the whole country and first of its kind in India to be started and run by a medical fraternity.

IMA Ponda has taken into consideration the administrative and financial constraints in running the project, more so because we will have to cater to the needs of deserving and needy persons, and so far we have no assurance from Government of Goa in terms of their support. We have appealed to the Government to consider our proposal affirmatively.

Hence we appeal to our professional colleagues and well-wishers to support DILASA in the best possible manner either by way of Corpus Donation, or by sponsoring utility items, adopting running cost of a bed, room, ward, financing of administrative cost and by helping in conducting regular training programs and health camps at the site.
